RE: RAPID PHASE-OUT OF LEADED PETROL AND COMMUNITY REPRESENTATION AT THE OECD JOINT MEETING IN MAY 1993

After recently meeting with four of Australia's five petrol refiners it is clear that a rapid phase out of lead in petrol will only occur if the Federal Government acts. All the petrol companies we spoke with indicated that it is not their responsibility to reduce lead in petrol but that they will always conform with legislation.

understand that CEPA has partially funded the NHMRC's Lead in Blood and Lead in Air Guidelines vet this issue urgently requires Study, leadership by the environment minister. Children's intelligence is being damaged now: it is essential is immediately permissible lead in petrol that brought down to European levels; closely followed by a further reduction to North American levels; and a definite date for final phase-out as in New Zealand (1996).

My previous letter (2nd February 1993) has not received a reply, yet some of the questions in it need urgent answers:-

delegation the Who Australian to in the Organisation for Economic Cooperation and Development (OECD) 20th Joint Meeting in Paris in May 1993? community groups have any faith extensive contributions to the OECD Cooperative Risk Reduction Document on Lead will be incorporated into the document, if no community representatives go to the Joint Meeting?

What action have you instigated through ANZECC and NEPA to set up a National Lead Taskforce with community representation whose task is to design an Australian strategy to eliminate childhood poisoning?
