Turkey			•	As of 2002, TUPRAS stopped production of leaded regular gasoline, lead content of Premium gasoline has been decreased from 0.40 g/l to 0.1 g/l and unleaded premium gasoline has a lead content of 0.013 g/l. Regulation TS 228, based on EN228 of 98/70/EC, completely bans use of leaded gasoline in 2006. It also defines full transposition of EU regulations related to fuel quality as of 2009, and calls for the replacement of lead by other additives. (REC Survey)
